## **Lessons in Litigation**

In June of 2012, I published a book whose title included the name of artist Claude Monet and one of the tools he used. It was a mystery about art and art forgery. A month or so after its release I had a message from someone who said she represented a company of the same name and that they owned the trademark. I was to "cease and desist" using the title immediately. I was also to fax her a signed paper saying I would remove the book from the internet and bookstores at once. I wasn't sure what to think, but because the message was fairly hostile, I saved it to my computer as an MP3 file.

I had done a search for the title while writing the book and didn't find anything. I decided to search again and still couldn't find anything with the same title. I did come across a company that had indeed trademarked a similar name, but one of the words was spelled differently and had an entirely different meaning. "Ah," I thought. "If that's the company involved they will realize they are different spellings and that will be the end of it." As frustrating as it was to be threatened over the phone, I believed they had just made a mistake. After all, how could my mystery interfere with their business? (I hesitate to state the name of the company for obvious reasons.)

A month later, I received a letter from an attorney representing the company. It basically restated the phone message and went on to point out the list of important people associated with their product. It also mentioned a couple of times that I was only (emphasis mine) a self-published author. The entire letter felt like one long empty threat, but I am not an attorney. Upon doing more research, I learned that trademark holders can challenge someone for being "confusingly similar." In my non-attorney mind, no one would confuse my product with theirs, but I decided to find professional help. I hired an attorney to respond to the letter.

As an aside, the contract to secure the services of my new attorney offered another reminder of how different my world is from big business and corporate America. On the bottom of the contract was a statement suggesting that I have an attorney look it over before signing. Yes, I laughed. How could I not?

The next step was for my new attorney to write a letter to their attorney stating that they didn't have a case, I believed that would be the end of it. Unfortunately, their attorney responded that they didn't agree and they would take necessary action to protect their client's trademark. For me, it was time to make a decision. I am 63, and although I don't let that stop me from celebrat-

ing life, I don't make the same decisions I did when I was 21, or even 41, especially when picking my battles.

As I considered the situation, I realized I was far more upset about being bullied than I was at the thought of redoing the title and related artwork. The waste of time, energy, and money wasn't a pleasant thought, but what was I willing to risk financially and emotionally to fight a bully? I have experienced enough of life to know there are those who live in a world of lack and fear. They spend a great deal of energy protecting themselves from everyone they perceive to be attacking, that is usually everyone. I decided it was time for me to pull the book from the marketplace and move forward.

To indie authors who are concerned, U.S. Copyrights do not protect book titles because courts do not believe a book title has "a significant amount of original expression" to warrant protection. This was a trademark issue, not a copyright issue, so it might be wise to do a trademark search. According to the United States Patent and Trademark Office a trademark is, "A word, phrase, symbol or design, or a combination of words, phrases, symbols or designs that identifies and distinguishes the source of the goods or services of one party from those of others." You cannot call your book a Nancy Drew Mystery Story<sup>®</sup> because that phrase is a registered trademark. You can call it The Haunted Bridge (a Nancy Drew title), but be careful that a book title hasn't become a recognizable brand. That might earn it trademark protection. You wouldn't call your book *To Kill a Mockingbird* anymore than you would call your elderly detective *Miss Jane Marple*.

My attorney believed that if we had gone to court, we would have won. Since he wasn't willing to work for free, I couldn't take the chance. A few friends have said they would have continued fighting. I believe they would have been safe in doing so. What made my decision a little easier is that with 40 years experience as a Graphic Artist, I knew I could redo my cover and text files without incurring those costs. It was *the path of least resistance*, and I'm comfortable with my choice.

I like to think that every experience in life offers us a chance to mea-



sure our growth. I have grown. I put my energy into improving the book and released it with a new title. If you're curious, the new title is *An Uncluttered Palette*.

## Who Is Veronica Esagui?

Interview by Connie Hill



**Dr. Veronica Esagui** is the critically acclaimed author of *The Scolio*sis Self-Help Resource Book, in English and Japanese. Her diaries are, *The Journey of In*nocence, Braving a New World, Awakening the Woman Within and the soon-to-be-released

Angels Among Us and The Gift. Journey of Innocence details her growing up years in Portugal and coming to the US in an arranged marriage. In Braving the New World she becomes Americanized, has children, gets involved in and helps the community, and becomes a music teacher and music store owner. In Awakening the Woman Within she discovers chiropractic, goes back to school to become a chiropractor, gets divorced and tries out dating-she never experienced dating as a teen! The last of her book series Angels Among Us and The Gift are presently being translated from Portuguese to English.

About her journals Veronica says: "I've always told stories. I grew up in a storytelling culture with no radio or TV. When I met my present husband I would tell him stories and he'd say 'Oh, that is funny or inspiring. You need to translate those stories into English so others can enjoy them.' So I'm working on the final two books now. When I'm done there will be five books. Once we get to the age of 50 we become time travelers and these are me time traveling!"

Veronica is also the founder of the NW Book Festival, NWPA (Northwest Writers and Publishers Assn), and the *Author's Forum*, an interview show of local authors on public access TV.

**Connie:** Hi Veronica. This year's NW Book Festival is coming up next month on Saturday, July 26 from 11-5

PM at Pioneer Courthouse Square in downtown Portland. What can you tell me about the book festival? You said it started in your parking lot?

**Veronica:** There were two reason I began it. The first was about the horror of publishing my first book with Publish America. The second, was a way to get the word out about my books to the world.

After I republished my books myself I had a giant bonfire and burned all of my Publish America books. But every option to publicize my books was \$400-600 a weekend. What was left to do? A thought came to me that I could use my business parking lot for free. The word went out and 40 authors showed up, including the mayor of West Linn with her book!

We used our parking lot and one or two others. I sent out press releases and a local CATV station showed up. Each author did a 10 minute talk about their books inside my office because it was quiet and the station videotaped the whole thing. It was awesome and we had a blast.

**Connie:** Why did you change the location after that first year?

**Veronica:** The beauty shop next door was unhappy that their customers couldn't get in because the parking lots were so jammed. After driving around Portland looking for a new space I approached Pioneer Square and they said yes. We moved down there in 2009 and they actually want us back each year because it does so much for the city. People come in from all over to visit. Last year Ben & Jerry's gave out over 3000 ice cream samples, which means there were more than 3000 people who attended.

This is the sixth year and we sold out of booth spots more than a month early. That means several hundred authors are coming with books. Some booths will have one person, but most will have 3, 4, or 5 authors and each publishing companies may have 20 authors attending.

**Connie:** I know it's going to be a great success. Veronica, another group you started was NWPA. Can you tell me what was your vision for the organization?

Veronica: I was in several groups for awhile, some good and some not so good, meaning some were useful and some I wondered why I even signed up for them. One group met in Lake Oswego and was probably my favorite of all the groups. They had a speaker each month. But there were some political and financial problems.

When I left that group I realized I wanted to start one that had the same kind of philosophy as well as some positives from the other groups I'd been a member of. I like groups that run without politics or jealousy and without someone controlling them. So I have tried to have that be part of NWPA, NW Book Festival, my theater groups and my office. People may say I'm the one in charge of NWPA but I want members to be part of running it.

My original thoughts were "How can we help each other? How can beginning writers come into the group and not be intimidated because of jealousy, or other members feeling they are better than others or knows it all. I want people to join and share and help each other.

**Connie:** Who are some of your favorite speakers?

**Veronica:** We've had some incredible speakers! David Koop, was inspiring. His information was so motivating.

He said to never give up. Carolyn Rose and Mike Nettleton, who have spoken twice talked about how to write well and were inspiring as well. Jill Kelly, who talked about editing, was very, very good. And Nancy McDonald talked about bringing out your inner actor -after writing, authors need to become the actor to promote their books. Every writer needs to be able to talk about their book and that's what publishers look for. Oh, and another one was about getting the word out, featuring Kjerstin Gabrielson with Oregon Media Group, Cindy Dawer with West Side Cultural Alliance and Sandra Sorenson reporter for the Tualatin Times. They were very helpful.

Sometimes a speaker comes in and just talks about themself. That doesn't make me very happy. It's not about one person, but about the group. What can each speaker share with the group?

Connie: One thing that came out of the first book festival was your CATV show. Tell me about Author's Forum.

**Veronica:** The CATV station that came and recorded the author talks asked me if I'd be interested in doing a show on their station. Of course I said YES. That was the birth of Author's Forum and new episodes are available on public access TV each month. Nearly 70 shows are available on my website:

www.veronicaesagui.net. More should be available by the end of the summer.

Connie: Since you work so much with books and authors who are some of your favorite authors or books?

Veronica: My very favorite book is called *The Egyptian* by Mika Waltari. Then my mother's poetry books and stories. One of my present favorite authors is Amalie J Rush Hill, who wrote Ambolaja Into the Light and Discontinuity. I love my friend Jean Sheldon's mysteries, especially her latest, Puzzled by the Clues. And I love to read health books, especially The Herbal Drugstore. I love that book because it gives you the herbal way and also the medical way, so you have a choice. Right now I'm enjoying the poetry of Earlene Gray (Musings with a Cuppa—The Poetry of Tea).

Connie: What an interesting and diverse group of books! Is there anything else you want to say before we end?

Veronica: Yes. Everything is perception. If your perception is that you are not good enough or you're not going to make it, then that will happen. You always have to reach for the top, surrounded yourself by good, inspiring people who promote you and don't bring you down. With that there is no reason you can't be successful in everything you do.

Another thing, everyone has to stay open minded and write what's in our hearts. If you have ideas but not the writing skills, take a writing class or get someone to help you. I also think there are really no rules about writing, except bad spelling or really bad grammar. There is a Portuguese writer, Jose Saramago, who wrote Blindness. His sentences just go on and on and on, but he won a nobel prize for his writing! And he is a great example of not following the rules. Whatever is your passion, keep doing it!

Connie: Thank you Veronica. And those who are reading this, I hope to see you at this year's 6th Annual NW Book Festival at Portland's Pioneer Courthouse Square. Learn more about NWPA at booth #64.

## **Review of Parentheses**

Our lives are busy and often our *to do* lists are discouragingly long. Perhaps that's why an unexpected delightful experience is such a treat. I must admit that when I started NWPA member Fredrick Swan's book about his death, I wasn't sure it was something I would be comfortable reading. I couldn't have been more mistaken. In *Parentheses: A memoir of my life before, during and after my death,* Swan offers more than the simple recounting of a medical miracle, a powerful story on its own. He uses artistic sensibilities and a delightfully subtle wit to create a story of our human capacity to triumph over challenges—even when we don't recognize the challenges or the triumphs. I found myself rereading and taking notes on his many hard-earned insights. A personal favorite—"certainty is the most vulnerable of anyone's beliefs." This is a story about miracles, not just of our remarkable physical resilience, but also of that undefinable essence, the spark that understands miracles are an everyday occurrence. I highly recommend this book to…well, to everyone.
